# FUNDING MAY BE USED FOR

The following activities related to a commercial child care or preschool facility in Ventura County:

- Planning
- Construction
- Expansion
- Rehabilitation

## TERMS & ELIGIBILITY

- Loans may range from \$10,000-\$800,000
- Maximum loan term 84 months
- \$200 loan origination fee, plus out-of-pocket expenses
- Three years of financial statements and/or projections
- Letter of loan rejection from bank
- Collateral for loans such as personal real estate of guarantor and/or any assets purchased by the loan and UCC-1 filing on all business assets
- Funds may only be used for the development of commercial spaces
